WAIVER AND RELEASE OF LIABILITY AND AGREEMENT TO PARTICIPATE

In consideration of being permitted to participate in any way, including travel to and from, in any Judo tournament, practice, clinic, and related events and activities of United States Judo, Inc., United States Judo Federation, United States Judo Association, Pennsylvania Judo, Inc., Kim's Martial Arts, Inc. and/or University of Pittsburgh, I hereby:

1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo.
2. Agree that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, the clinician, and/or a tournament official of such conditions and refuse to participate.
3. Acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including permanent disability or death, and severe social and economic losses due to not only my own actions, inactions, or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, I assume as such risk and accept personal responsibility for the damages following such injury, permanent disability, or death.
5. Release, waive, discharge and covenant not to sue the United States Judo, Inc., United States Judo Federation, United States Judo Association, Pennsylvania Judo, Inc., Kim's Martial Arts, Inc., University of Pittsburgh, together with their affiliated clubs, their respective administrators, directors, agents, coaches and other employees or volunteers of the organization, event officials, medical personnel, other participants, their parents, guardians, supervisors and coaches, sponsoring agencies, sponsors, advertisers, and if applicable, owners, lessors and lessees of premises used to conduct the event, all of whom are hereinafter referred to as: "releasee", from any and all claims, demands, losses, or damages on account of injury, including permanent disability and death and damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise to the fullest extent permitted by law.

I HAVE READ THE ABOVE WARNING, WAIVER AND RELEASE, UNDERSTAND AND THAT I GIVE UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND KNOWING THIS, SIGN IT VOLUNTARILY. DIRECTIONS TO UNIVERSITY OF PITTSBURGH TREES HALL

From the North:

- Take 179 South to Exit 72/1279 South (exit on left)
- Take 1279 South to Exit 8A/1579 South
- Take the exit for 1376 East (Oakland/Monroeville – exit on left)
- Stay straight to go onto the Blvd of the Allies
- Take the Forbes Ave Exit
- Turn Left onto McKee Place
- Follow directions at the bottom (see map)

From the South:

- Take 179 North to Exit 59A/1279 North
- Take Exit 6A/1376 East/Monroeville
- Take Exit 2A/Forbes Ave/Oakland
- Turn Left onto McKee Place
- Follow directions at the bottom (see map)

From the Northwest:

- Take 180 East to Exit 19A/179 South and follow the directions from the North.

From the Southwest:

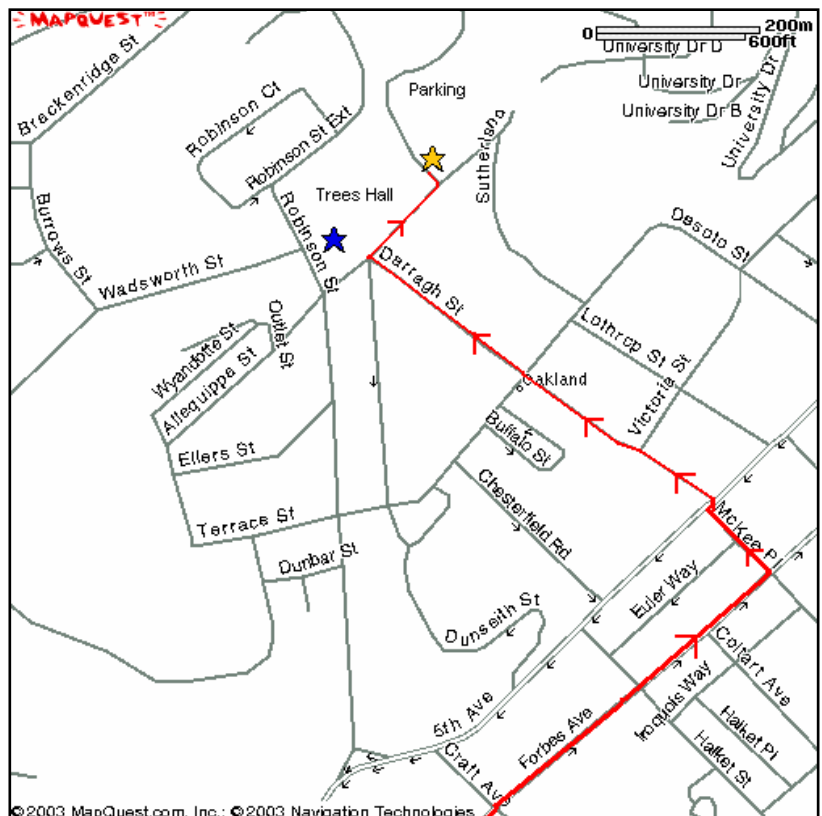
- Take 170 East to Exit 18/179 North and follow the directions from the South.

From the East:

- Take 176 West to Exit 57/1376 West toward Pittsburgh
- Take the Exit 3B/Oakland and bear right onto Bates Street
- Stay straight through the traffic light
- Take the second left onto McKee Place
- Cross Forbes Ave at the traffic light
- Follow directions at the bottom (see map)

From McKee Place:

- Cross Fifth Ave at the traffic light and McKee Place becomes Darragh Street
- At the very top of the hill (and a traffic light) you will be facing Trees Hall
- To park, turn right onto Allequippa Street and then turn left into the University of Pittsburgh OC Lot (Cost: \$5-\$7)
