3. Shime waza allowed for 13 yrs. of age and up
4. Kansetsu waza allowed in all senior divisions  
regardless of age. (min. age for Sr. div. is 13)
5. 2002 Medical Rules
6. Must be in Judo Gi to receive your Trophy

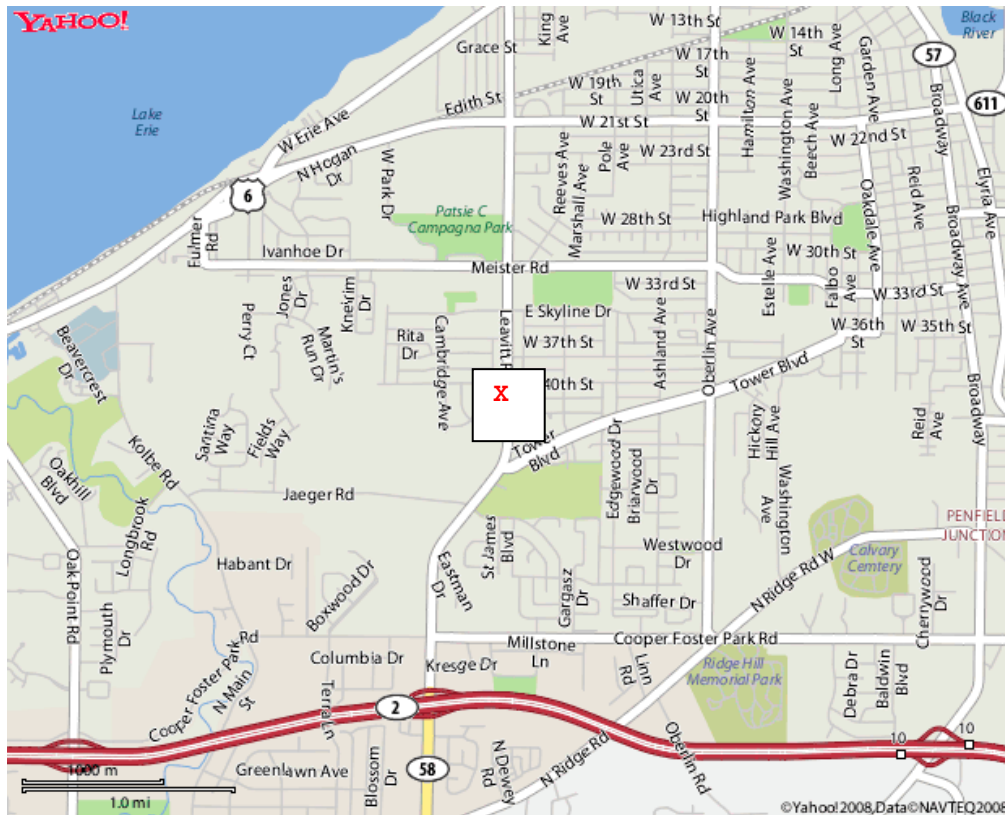
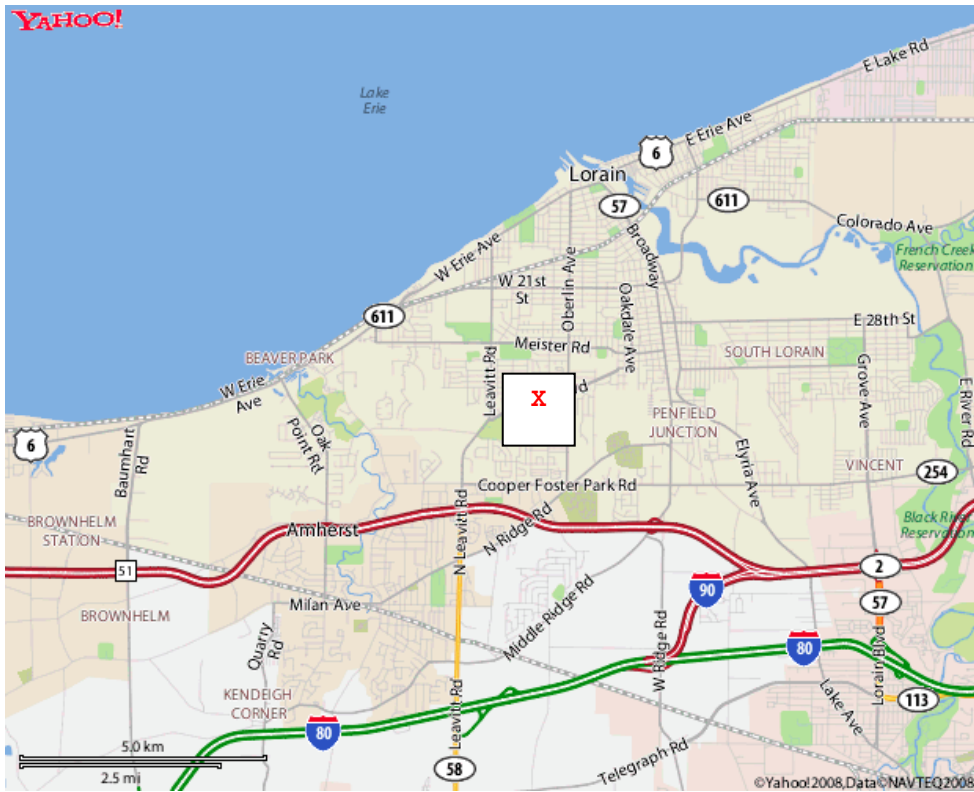
