1. ACKNOWLEDGE THAT I AM FAMILIAR WITH THE SPORT OF JUDO AND UNDERSTAND THE RULES GOVERNING JUDO.
2. AGREE THAT PRIOR TO PARTICIPATING, I WILL INSPECT THE MATS, EQUIPMENT, FACILITIES, COMPETITION POOLS OR DIVISIONS AND THE ELIMINATION OR SCORING SYSTEM TO BE USED AND, IF I BELIEVE ANYTHING IS UNSAFE OR BEYOND MY CAPABILITY, I WILL IMMEDIATELY ADVISE MY COACH AND A TOURNAMENT OFFICIAL OF SUCH CONDITIONS AND REFUSE TO PARTICIPATE.

ACKNOWLEDGE AND FULLY UNDERSTAND THAT I WILL BE ENGAGING IN A CONTACT SPORT THAT MIGHT RESULT IN SERIOUS INJURY, INCLUDING PERMANENT DISABILITY OR DEATH, AND SEVERE SOCIAL AND ECONOMIC LOSSES DUE TO NOT ONLY MY OWN ACTIONS, INACTIONS OR NEGLIGENCE, BUT ALSO TO THE ACTIONS, INACTIONS OR NEGLIGENCE OF OTHERS, THE RULES OF THE SPORT OF JUDO OR CONDITIONS OF THE PREMISES OR OF ANY EQUIPMENT USED.
