AGREE THAT PRIOR TO PARTICIPATING, I WILL INSPECT THE MATS, EQUIPMENT, FACILITIES, COMPETITION POOLS OR DIVISIONS AND IF I BELIEVE ANYTHING TO BE UNSAFE OR BEYOND MY CAPABILITES I WILL IMMEDIATELY ADVISE MY COACH AND THE TOURNAMENT DIRECTOR OF SUCH CONDITIONS AND REFUSE TO PARTICIPATE IN THE COMPETITION.

ACKNOWLEDGE AND FULLY UNDERSTAND THAT I WILL ENGAGE IN A CONTACT SPORT THAT MIGHT RESULT IN SERIOUS INJURY INCLUDING PERMANENT DISABILITY OR DEATH AND SEVERE SOCIAL AND ECONOMIC LOSSES DUE TO NOT ONLY TO MY OWN ACTIONS, INACTIONS, OR NEGLIGENCE, BUT ALSO AS A RESULT OF THE ACTIONS, INACTIONS OR NEGLIGENCE OF OTHERS.
