

PROMOTION REQUIREMENTS:

- 1) Must be registered USJI/PJI members in good standing.
- 2) Must meet minimum promotion requirements established by USJI/PJI.
- 3) Written exams required for senior Sankyu through Shodan ranks.
- 4) Promotions of Yodan or higher must be recommended by PJI State Promotional Board to the USJI National Promotional Board.
- 5) Junior promotions must meet minimum promotion requirements established by PJI.
- 6) All non-members will be promoted provided they meet all the above requirement and the fees have been paid. USJA and USJF ranks are recognized as of the date of original adoption of USJI/PJI procedures (5/1/83).

REGISTRATION:

- 1) State Promotion Board (normally for Sandan or higher) - Candidate Promotional Chairman/Club Promotional Board/or candidate's Instructor must submit a Form PJ-2 to State Promotion Board Chairman 30 days in advance of examination. Chairman must submit Form PJ-1 to PJI Registrar with proper fee.
- 2) Regional Promotional Board (normally for Shodan and higher) - Candidates/Club Promotional Board/or candidate's Instructor must submit Form PJ-2 to Regional Promotional Board Chairman 30 days in advance of examination. Chairman must submit Form PJ-1 to PJI Registrar with proper fee.
- 3) Club Promotional Board (Shodan or lower) -Candidates/or candidate's Instructor must submit Form PJ-2 to Club Promotional Board Chairman at the Boards digression. Chairman must submit Form PJ-1 to PJI Registrar with proper fee.
- 4) Instructor Promotional (all junior ranks and senior to Sankyu) - Candidate's registration is at the digression of the Instructor. Chairman must submit Form PJ-1 to PJI Registrar with proper fee.

RECORDING PROMOTIONS:

- 1) All Dan promotions are to submitted to the PJI Registrar -Dan Promotions.
- 2) All Kyu promotions are to submitted to the PJI Registrar Kyu Promotions.
- 3) Information submitted must include
 - a) Form PJ-1 (all rank promotions)
 - b) Form P2-2 (all Dan rank promotions)
